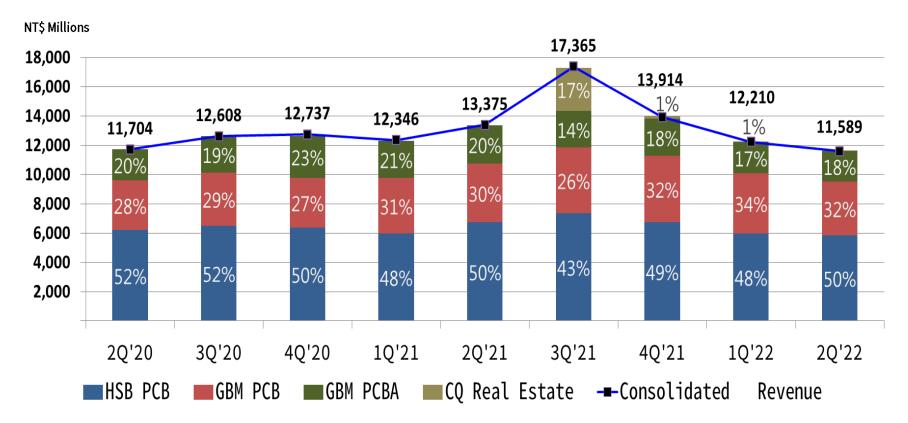

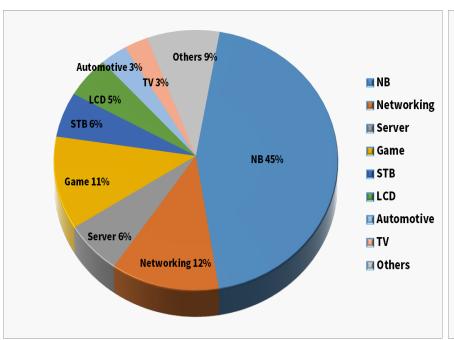

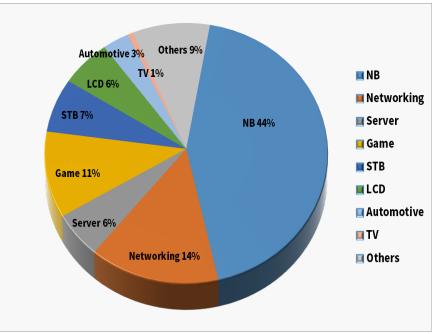
#### Consolidated Revenue Structure (HSB+GBM)
